

### Auditor's Responsibility



Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal controls relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal controls. The trustees present their report for the year ended 28 February 2009. This report forms part of the audited financial statements.

**1. Object of trust and nature of business**

There were no changes in the nature of the trust's business during the year under review.

The object of the trust is to create a fund, the assets and income of which are to be devoted wholly to the development and construction of a VISION 2020 Eye care unit at the MAHTMA Ghandi Memorial Hospital for treatment and prevention of cataract and other eye-related diseases and disorders, to conduct or promote eye care training programmes and activities ancillary thereto for the benefit of the beneficiaries.

No profits or gains of the trust may be distributed to any person, but shall be retained and applied to the promotion or furtherance of its object.

The activities of the trust shall be wholly or mainly confined to the Province of KwaZulu-Natal in the Republic of South Africa and shall be wholly or mainly directed to the attainment of its objects and its funds shall be applied within the said area.

On winding-up, the capital and retained income of the trust must be distributed to an institution with similar objects.

**2. Statements of responsibility**

The trustees are responsible for the maintenance of adequate accounting records and the preparation and integrity of the financial statements and related information. The external auditors are responsible for independently auditing and reporting on the fair presentation of financial statements in conformity with International Standards on Auditing. The financial statements have been prepared in accordance with South African Statements of Generally Accepted Accounting Practice.

The trustees are also responsible for the trust's system of internal financial control. These are designed to provide reasonable, but not absolute, assurance as to the reliability of the financial statements, and to adequately safeguard, verify and maintain accountability of assets, and to prevent and detect misstatement and loss. Nothing has come to the attention of the trustees to indicate that any material breakdown in the functioning of these controls, procedures and systems has occurred during the year under review.

The financial statements have been prepared on the going concern basis, since the trustees have every reason to believe that the trust has adequate resources in place to continue in operation for the foreseeable future.

**1 Basis of preparation**

The financial statements are prepared in accordance with South African Statements of Generally Accepted Accounting Practice.

The preparation of the annual financial statements in conformity with SA GAAP requires the use of estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period based on management's best knowledge of current events and actions. Actual results may ultimately differ from these estimates. During the current year, there are no areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements.

**1.1 Property, plant and equipment**

All property, plant and equipment is stated at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset as appropriate, only when it is probable that future economic benefits associated with the item will flow to the trust and the cost can be measured reliably. All other repairs and maintenance are charged to the income statement during the financial period in which they incurred.

Depreciation on other assets is calculated using the straight-line method to allocate their cost to their residual values over their estimated lives as follows:
